- (12) The school building plan must have been approved by the current rules or G.Os. The School building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respects are the whole responsibility of the managements.
- (13) The School is run by a society registered under the Tamil Nadu Societies Registration Act, 1975 (Tamil Nadu Act 27 of 1975), or a public trust constituted under any law for the time being in force;
- (14) The School is not run for profit to any individual, group or association of individuals or any other persons;
- (15) The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared. A copy each of the Statements of Accounts should be sent every year to the competent authority granting recognition.
- (16) The recognition Code Number shall be quoted for any correspondence with the competent authority.
- (17) The School shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the School;
- (18) Tamil shall be taught as a subject from in Standards I to X in all schools notified under sub clause (iv) of clause (e) of section 2 of the Tamil Nadu Tamil Learning Act. 2006 (Tamil Nadu Act 13 of 2006) in a phased manner Commencing from the academic year 2015-2016 for standard I, from the Academic year 2016-2017 for standard I and II and shall be extended up to Standard X in a like manner as ordered in a reference (5) cited as Follows:

- (19) The school shall abide by the provisions of the Tamil Nadu Recognized Private Schools (Regulation) Act 1973 and Tamil Nadu Recognized Private Schools (Regulation) Rules 1974.
- (20) The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/time.
- (21) The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
- (22) The Management shall apply for renewal of recognition three months before the expiry of this order to this Directorate through the Chief Educational Officer of the district concerned.
- (23) The management shall follow the directions issued by the Government/Department from time to time keeping in view of the safety and security of the children and the overall administration of the School.
- (24) The recognition shall be withdrawn if any contravention of the provisions of the Act, Rules or the conditions of recognition are found and proved.
- (25) The School Management Shall have to full responsibility if any court case arise this regard. This order may be used only for the purpose of seeking affiliation to **Central Board of Secondary Education** as requested by the management and the management is not entitled to seek affiliation to any other Board.
