

- (c) To make, construct, build, purchase furniture, libraries, equipment and all other articles as may be necessary for the institute(s) or institution(s) and collect and receive endowment or endowments for the running, maintenance or expansion of the same.
- (d) To establish and maintain Industrial Homes for men and women and to train them in arts, handicrafts and home industries including carpentry, joinery, designing, drawing, painting, re-work, carpet-making, spinning, weaving etc and teach them as technicians for manufacture of art products, mechanical engineers, carriage builders, and all other industrial and manufacturing arts and handicrafts as the Trustees may deem fit and to provide for payment to the daily, weekly or monthly wages or such wages and allowances, bonus and remuneration as the Trustees may determine from time to time.

shares or companies, Public or Private, Debentures of Companies, first mortgage or immovable properties in the State of Tamil Nadu and/or other States in the Indian Union, by way of loans and/or advances to individuals, firms or companies on the security of promissory notes or otherwise, or in such other manner as the Trustees may think proper.

(c) Management. (i) Mr. A. M. Ramanathan, (ii) Dr. S. P. T. Iyer, (iii) G. S. Shukla and (iv) L. V. K. Rao will be the members of the Executive Committee of the Trust. The Executive Committee shall have the power to make rules for the conduct of the affairs of the Trust. Further, for additional trusteeship, with the approval of the above-mentioned members of the Executive Committee, the Executive Committee may nominate additional trustees. The nomination of such additional trustees shall be subject to the following conditions: (i) that the nominees shall be persons of good character and reputation; (ii) that they may be persons among whom no one will be connected with any business or profession which may be considered as likely to bring discredit upon the Trust; (iii) that they shall be persons who are willing to serve the Trust without remuneration.

(d) Mr. Ramanath Goenka shall be the Chairman of the Trustees for life and Mr. Anupam Bhattacharya shall be the Chairman of the Executive Committee of the Trust. He shall be responsible for the conduct of the affairs of the Trust. He shall be the Managing Trustee for his term and thereafter the trustees.

(e) Subject to such rules as may from time to time be made by the Trustees, the affairs of the Trust shall be conducted and its objects carried out by the institution of a trust under its control managed by a person or persons to be nominated by the Trustees to be called "the Manager".
